**ORDER**

The 1<sup>st</sup> hearing held on 28<sup>th</sup> November 2024, related the APIC No. 237 /2024. The Appellant Shri Takam Dado, and the representative of the PIO Shri Majik Talit RFO, also present during hearing.

Heard both the parties

The Appellant reported to the Commission that the Appellant has received half of the information from the PIO, as sought by in his form 'A' application. He stated that as per the sanction order, an amount of 1 Crore 29 lakhs was allocated the financial year 2023-2024. However, only 84 lakhs has been spent to shown up but remaining amount was not shown. The Appellant want to know where the remaining amount has been utilized, kindly provide the Cheque numbers along with Xerox copies of the same verification.

Heard the PIO.

The PIO stated before the Commission that they cannot provide to all small amount receipt only they provide to a Xerox copy of the Cheque number for the payment details.

After hearing both the parties and going through the form 'A' application of the Appellant, the Commission ordered;

(i) The PIO to provide all the remaining information to the Appellant as sought by in his form 'A' application on or before next date of hearing. **Failing which action 20(2) shall be initiated against the PIO as per the provisions of RT Act, 2005.**

(ii) The Appellant after going through the information received, intimate the Commission whether he has received full information or not on or before next date of hearing.
