



## **ARUNACHAL PRADESH INFORMATION COMMISSION**

### **SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram & party for non-furnishing of below mentioned information by the PIO o/o the Executive Engineer ((EE) PWD Sangram Division, Kurung Kumey District, Govt. of Arunachal Pradesh, as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 22.08.2024.

1. Particulars of information : To furnish all the relevant information against RE/BE.

**Details of Information Required:**

1. Furnish the list of scheme.
2. Name of work list with Geo-tag report/sanction order/technical sanction (TS) order copy.
3. Details of project report (DPR) / estimate copy.
4. Furnish the list of work order copy with cheque book foil/leaf/demand draft/banker Cheque/deposited slip/challan and PFMS transaction details as according to the amount Which mentioned in work order/sanction order/name of work list.
5. Name of contractors/firm/enterprise with their bank account number.
6. Give the deposited slip/voucher/treasury challan of GST amount/money which deposited to Govt. account against Royalty by firm/enterprise account with GST updates.
7. Photo copy of all the trading license/firm/enterprise.
8. Furnish the deposited slip/challan/voucher/transaction of GST money deposited to Government Account against Royalty by Executive Engineer, Division Account/firm/enterprise account and also mention the owner name of firm/enterprise/proprietor name, Give reasons what firm/enterprise owner/proprietor is to AE/JE who run the Firm/Enterprise ?
9. Details of payment with money receipt of contractors/firm/enterprise.
10. Bank account statement of EE Division with its Account number.
11. Give the letter/petition/LOC/LOA which write to the branch manager of SBI to release of fund to EE Account by CE, PWD.



12. Measurement Book with page number/hand receipt and payees name.
13. First and final bill copy/Give the name of various deduction as percent from contractor payment.
14. Photocopy of work site before starting of work/completion of work site with exact location.
15. Certified photo copy of all work site by concern officer.
16. Name of offices and officials who handled/executed the works.
17. Description of work site location before start of work.
18. Billing details sheet copy of work.
19. Give the bank account statement and transferred to Reserve bank account of various AE, Sub-Division from EE bank account of division/firm/enterprise account with its bank account number.
20. Give the list of AE/JE of department with their used firm/enterprise
21. Furnish NIT copy/Date of NIT tender float/Total number bidder/total apply of firms/name of selected firm/enterprise and contractors/press letter paper cutting/awarded firms details/cheque book counter foil/leaf with account number of firm or contractor to whom the payment has been made /UC.

Period from which information asked for : 2023 to 2024.

**Brief facts emerging from the appeal :**

Records emerging from the appeal disclose that the Appellant, Shri Riya Taram had requested the PIO for the aforementioned information/documents but failed to obtain the same which prompted him to appeal before the Chief Engineer (CE), Central Zone A, PWD, Itanagar, Papum Pare District, Govt. of Arunachal Pradesh, the First Appellate Authority (FAA) under Section 19 (1) of the RTI Act, 2005 vide Memo of Appeal Dated 22.08.2024. However, the appellant having failed yet again to obtain the information preferred 2<sup>nd</sup> appeal before this Commission under Section 19 (3) of the RTI Act. 2005 vide memo of Appeal dated 19.11.2024.

This appeal was accordingly, listed for hearing on 23<sup>rd</sup> Jan, 2025 for hearing wherein both the appellant and the respondent PIO were absent. However, Shri Bini Tare, PA-cum-in-charge RTI cell, PWD, Sangram, appeared on behalf of the PIO who submitted that the sought for information /documents is very voluminous and hence requested for 45 days time to furnish the information. In this regard, it is observed that the FAA also heard this appeal on 13.11.2024 and by order dtd. 18-11-2024 the FAA has rejected the appeal on the ground that the application sought is for various projects and is voluminous and not for "one scheme and one financial year".

The Commission observed that the information sought is for one scheme funding program under state plan BE & RE for one financial year 2023-24 which could be provided to the appellant. Therefore, the PIO was directed to furnish the information to the appellant within 30 days from the date of issue of order, dt. 18.11.2024 i.e on or before 23.02.2025.

However, there is no information either from the PIO or the appellant. The appeal is, therefore, listed on 05.09.2025.

**NOW, THEREFORE,** You are hereby summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, **SIC in person on the 5<sup>th</sup> of September, 2025, at 2 pm** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
