SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bamang Pacho, Forest Park, Near Main Powerhouse, House No. IMC-491, W-10, Itanagar, Arunachal Pradesh for non-furnishing of information by the PIO, o/o the BDO, Sarli CD Block, Kurung Kumey District, Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 03.02.2023.

This appeal is heard today on 27/11/24 wherein the Appellant Shri Bamang Pacho is present but the PIO, o/o the BDO, Sarli C.D Block, Kurung Kumey Shri John Diru is absent who has sent message dated 26/11/24 through WhatsApp informing that he is in Shillong attending a training programme at IIM Shillong from 25/11/24 to 30/11/24 and requested for adjournment of the hearing to next date.

The Appellant Shri Bamang Pacho, expressing his utter disappointment and dissatisfaction on non-appearance of the PIO in the hearing and failure to provide the sought for information despite the order of this Commission, pleaded for stringent action under the RTI Act against the PIO.

This Commission also observes that the PIO has not been attending the hearing for continuously 6 times including today which has been viewed seriously by this Commission.

This Commission, therefore, issues stern warning to the PIO that if he fails to attend the next hearing, necessary action under Section-19 (8), (c) r/w Section-20 of RTI Act,2005.

As already directed earlier the PIO is again directed to provide the sought for information to the Appellant within 3(weeks) from today and appear in the next hearing fixed on **20/12/24 at 02.00 pm.**
