The 7th hearing was held on 4th September, 2024 related to the APIC No-554/2023 (Appeal). Both the parties, appellant Shri Lokam Namdu and PIO-cum-Executive Engineer, (PHE & WS) Sangram Division found absent during the hearing without any intimation to the Commission.

On 6th hearing dated 31/7/2024, the Commission issued Last Warning Show Cause Notice to the PIO as to why not impose the Sub-section-1 of the Section-20 against the PIO for the gross violation of the Sub-Section-1 of the Section-7 of the RTI Act, 2005, but he failed to reply the same.

Last Show Cause Notice is issued to the PIO to be present in person before the Commission in the next date of hearing. PIO is also directed to furnish all the information as sought by the appellant on or before next date of hearing. If, PIO fails comply the direction of the Commission, necessary action shall be taken against him as per the RTI Act, 2005.

The Commission directs the appellant to be present in person before the Commission in the next date of hearing. If appellant fails to present in the next hearing, his appeal case will be decided ex-parte and dispose off in his absence.

The Commission fixed next date of hearing on 09/10/2024 at 2 PM hours.
