## **SUMMON**

WHEREAS, in connection with the APIC-No. 02/2025 (C), your personal appearance is required before the Commission on 19th August, 2025 at 02:30 PM. The 1st hearing held on 8th May '2025. The Complainant, Shri Debia Torum, found absent during the hearing and PIO-cum ADC Yachuli, District Keyi Panyor District Govt. of Arunachal Pradesh, , also absent without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides, public duties also has to attend Court hearing when an appeal is preferred against him as per the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO.

The Commission seriously viewed the absence of both the parties and hereby orders;

- I. To send summon notice to the PIO to provide all the information(s) to the Appellant on or before the next date of hearing as sought in his form'A' application. Failing which necessary action shall be initiated against the PIO as per the provisions of the RTI Act 2005, and to be present in the next date of hearing.
- II. To send summon notice to the Complainant to appear before the Commission in person or through online mode in the next date of hearing. Failing which his appeal shall be decided ex-parte.
- III. Due to absence of both the parties, the Commission could not proceed the hearing of the appeal.

The Commission ordered:

The next date of hearing be fixed on 19th August 2025 at 2:30 PM(Afternoon).
