ORDER

The 5th hearing held on **14th November, 2024** related to the **APIC No-93/2024**. The Appellant Shri Tania June and the PIO-cum-Under Secretary, RWD, Civil Secretariat, Itanagar, Govt. of Arunachal Pradesh, are present in person before the Commission, during the hearing.

Heard the Appellant and the PIO:

The PIO informed the Commission that he has sent a letter to the Appellant on 12.12.2023 to deposit Rs. 10/- as fee to the information, for which Dak Record is attached and displayed before the Commission in the hearing.
