The 11th hearing was held on 4th September, 2024 related to the **APIC No-417/2023 (Appeal)**. PIO-cum-BDO, CD Block, Lemiking present during the hearing, but appellant Shri Tasi Chader found absent during the hearing without any information to the Commission.

The appellant is directed to be present in person before the Commission in the next date of hearing. Failing which his appeal case shall be decided ex-parte and dispose off.

The Commission fixed next date of hearing on **09/10/2024 at 2 PM hours.**
