**WHEREAS**, in connection with the **APIC-No. 382/2024**, your personal appearance is required before the Commission on **18<sup>th</sup> November, 2025 at 02:30 PM**. The **2<sup>nd</sup>** hearing held on **7<sup>th</sup> August, 2025**. The Appellant Shri Dongru Tania is absent for the consecutive 2<sup>nd</sup> time without intimating the Commission the reason for his inability to attend the hearing.
