RIGHT TO INFORMATION

> The representative of PIO stated before the Commission that as per the provisions of Section 8(j) the information could not be disclosed as it was personal information of the third party individuals so, the NOC certificate of individuals are not provided to him. Moreover, the First Appellate Authority (FAA) also passed an order on dated 24.05.2024, the information(s) could not be disclosed as it comes under the purview of Section -8 (j) of RTI act, 2005.

After hearing the representative of PIO, the Commission ordered;

- The PIO that information(s) as applied by the Applicant do not come under the (i) provisions of Section 8 (j) of the RTI, Act, 2005 as the NOC is not a third party document. Whereas, NOC is issued by the public authority and not by a private authority. Hence, the NOC issued can never jeopardize the life of any individual and as records maintained by the public office are public documents denial of the same are illegal in fact.
- The PIO to provide the information(s) to the Appellant on or before the next date of (ii) hearing.
- Failing which Section 25 (5) shall be initiated against the PIO as per the provisions of (iii) RTI Act,2005.
- Next date of hearing has been intimated to both the parties. No formal notice required to (iv) be issued.
