ORDER

The 4th hearing held on 14th November, 2024 related to the APIC No-139/2024. The Appellant Shri Pem Dondup Thangkar and Shri Khandu Thongkar and the PIO-cum-Executive Engineer, PHE, Department, Dirang Sub-Division, West Kameng District, are present through online mode during the hearing before the Commission.

Heard the Appellant and the PIO:
