ORDER

This is an appeal filed under sub-section (3) of the Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Nabam Tapak on 09.03.2023 filed an RTI application in Form-A to the PIO-Cum-DDSE PALIN Kra-Dadi District AP, whereby, seeking various information as quoted in Form-A application.

Appellant being not received information from the PIO, filed the First Appeal before the First Appellate Authority O/o Dy. SPD ISSE/SSA Govt of AP on 01.05.2023.

Appellant again having not received the required information and decision from FAA, filed the Second Appeal before the Arunachal Pradesh information Commission on 21.06.2023. The appellant has not attached any order of decision or response from the FAA.

The Registry of the Commission (APIC), on receipt of the appeal, registered it as APIC-No.582/2023 (Appeal) and processed the same for its hearing and disposal.

Accordingly, this matter came up for 3rd hearing before the Commission Court today on 16.08.2024. Notice of hearing dated 28.06.2024 were served to PIO and the Appellant.

In this hearing of the appeal on 28.06.2024 the respondents PIO DDSE PALIN Kra-Dadi District AP absent. The appellant is represented by Shri Lolam Namdu with written authorisation.

Heard the Appellant's representative.

The representative of the appellant states that information is not yet received from the PIO.

On perusal of this appeal case file records, it is seen that:

On first hearing dated 24.11.2023 the PIO was represented by Shri Tanyang Komo DPC ISSE. Information document was brought to court by representative of PIO. Appellant was absent. The commission has directed the PIO to send the information to the appellant by post. In the second hearing on 25.1.2024 the PIO was absent and the appellant appeared. Appellant states that information is yet to receive from the PIO. Again, PIO was directed by the order of the hearing that he shall send the information to the PIO by registered post with AD Card.

Today the PIO has produced a letter of intimation to the appellant in his given address in the RTI application in form-A by registered post vide memo no. ED/KD/ISSE/RTI/RPLY-187/2020-21 dated 3rd April 2024 under intimation to this commission. In case the appellant is not in receipt of the said letter & the information, he shall collect the information documents from PIO's office with a copy of this order and submit a compliance report to this commission.

The hearing adjourned. Next date of hearing shall be fixed in due course of time after receipt of the aforesaid compliance report.

Take notice that, in default of appearance by PIO and Appellant during next hearing, the appeal will be heard and determined Ex-Parte or until further notice / order so as to enforce your appearance.
