## ORDER

WHEREAS, in connection with the APIC-No. 291/2024, your personal appearance is required before the Commission on 27th February, 2025 at 10:30 AM. The 1st hearing held on <u>12<sup>th</sup> December, 2024</u> related to the <u>APIC-No-291/2024</u>. The Appellants Shri Taram Kenji and Nangram Ganesh are found absent during the hearing without intimating reason for absence, to the Commission. - Notice be issued to the Appellant to appear in person or through online mode before (iii) the Commission in the next date of hearing, failing which the appeal will be decided Ex-parte.
