## **SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Palen Laa & Smt Yukar Yaga, C/o Jollang Near Sonam Nursery, P.O/P.S-Itanagar, Arunachal Pradesh for non-furnishing of information by the PIO-cum-EE, Dept. of Power Division Raga, Kamle District, Govt. of Arunachal Pradesh as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

This appeal is heard for the 6<sup>th</sup> time today on 4<sup>th</sup> September, 2024. The PIO Shri Ruchu Niji, Executive Engineer, Department of Power, Raga Division, Kamle District was present. The appellants were absent during the hearing but one of them, namely Shri Palen Laa turned up after the hearing.

The PIO submitted that he received the Summon order of this Commission dated 2<sup>nd</sup> August, 2024 a week before only because of which he could not take early action. However, he has written to both the Division (erstwhile Divisions which executed the schemes in question) at Ziro and Daporijo vide letter dated 29<sup>th</sup> August, 2024 requesting them to furnish the information to the PIO's office, Raga for onward submission and providing to the appellant. He however, requested this Commission to allow him at least one month time to collect all the information from the aforesaid two Divisions and furnish the same to the Appellants.

This Commission considered the request of the PIO and the next date of hearing is fixed on 4<sup>th</sup> October, 2024 at 02.00 PM.

**NOW THEREFORE**, the PIO-cum-EE, Deptt. of Power Division Raga Kamle District, AP is hereby summoned to appear in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC in person on the above date and time without fail.
