ORDER

The 2nd hearing held on **19th November, 2024** related to the **APIC No-224/2024**. The Appellant Shri Rania Nabam Hina and representative of PIO Tad Logi A.E. present during the hearing.

Heard both parties.

The Appellant stated before the Commission that the PIO has not furnished any of the information as sought by him in his form 'A' application till date.

The representative of the PIO stated before the Commission that, the information(s) sought by the Appellant is completely provided under the detailed project report (DPR) and he has brought a copy of the DPR along with him to provide the Appellant during the last hearing. However, the representative of the PIO could not hand over the said information(s) due to the absence of the Appellant in the hearing.

After hearing both parties and going through the form 'A' application the Commission ordered;

- (i) The representative of PIO to communicate with the Appellant and provide to full information(s) to the Appellant on or before next date of the hearing. ***Failing which necessary action shall be initiated against the PIO as per the provisions of RTI Act, 2005.***
- (ii) ***The Appellant after receipt of the information(s) to intimate to the Commission whether he has received full information(s) as ordered or not on or before next date of hearing.***
- (iii) The next date of hearing has been intimated both the parties. No formal notice required to be issued.

The Commission ordered;

The next date of hearing be fixed on 23rd January 2025 at 10:30 AM (Morning)
