ORDER

The 1st hearing held on **1st October, 2024** related to the **APIC No-223/2024**. The Appellant Shri Dongu Josh heard through online mode but the PIO found absent without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO besides public duties, also has to attend Court hearings when an appeal is preferred against him as per the provisions of the RTI, Act,2005, which is a statutory duty binding upon the PIO.

Heard the Appellant.

The Appellant stated before the Commission that the PIO has not furnished any of the information as sought by him in his form 'A' application till date.

After hearing the Appellant, the Commission seriously viewed the absence of PIO and ordered ;

- (i) To **summon** the PIO to appear in person or through online mode before the Commission in the next date of hearing.
- (ii) The PIO to provide all the information(s) to the Appellant on or before next date of hearing as sought in his form 'A' Application. **Failing which necessary action shall be initiated against the PIO as per the provisions of RTI Act, 2005.**
- (iii) Next date of hearing has been intimated to the Appellant. No formal notice required to be issued.

The Commission ordered;

The next date of hearing be fixed on 21st November, 2024 at 10:30 PM (Morning)
