The **11<sup>th</sup> hearing** was held on **3<sup>rd</sup> February, 2025** related to **APIC NO-554/2023(Appeal)**. PIO-cum EE(PHE & WS) has been represented by APIO-cum-AE Sangram Division but the appellant Shri Lokam Namdu found absent without any intimation to the Commission.

Complying order dated 09/12/2024 which penalty amount of Rs. 25,000/- (Rupees twenty five thousand) only was imposed against the PIO-cum- Executive Engineer (PHE & WS), Sangram Division and compensate amount of Rs. 5000/- (Rupees five thousand) to the appellant have already been paid today and receipt copy of the same is submitted by the PIO.

The PIO has stated before the Commission today that information as sought by the appellant is of for the last 10 years from 2013 to till date. He has stated that it is not possible to give information for such long period and many scheme which is also seen that the First Appellate Authority-cum-CE (Western Zone), PHE & WS, Itanagar has forwarded a letter to address to the Executive Engineer (PHE & WS), Sangram Division Kurung Kumey District stating that all the Executive Engineer of PHE & WS Division are having its own independent PIO and has requested the appellant to collect the information from the division itself.

Commission submission made by the PIO, the appellant is asked to curtail the information which he is sought and mention schemes and project specifically.

The appellant is directed to appear in person before the Commission in the next date of hearing.

The Commission adjourned the hearing and fixed next date of hearing on **17/03/2025 at 1030 hours.**
