ORDER/SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tania June for non-furnishing of information by the PIO, o/o the DMO, Siang District, Boleng (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 10.10.2023.

The appellant herein had requested the PIO for the following information:

1. Subject matter of information required: -Regarding appointment of under Field Worker (FW)/ Regular Field Worker (RFW)/ Supervisor field worker (SFW)/ANM/ of entire Siang District.
2. Details of information required: -
 - (i) Furnish appointment order copies
 - (ii) Furnish joining report copies
 - (iii) Furnish class x pass certificate copies
 - (iv) Furnish class xii pass certificate copies.
3. Period from which information asked for; 2017 to till date.

The appeal was listed for 2nd time today on 6th December, 2024 the first being 20th November, 2024 when both the appellant and the PIO were absent.

In today's hearing also the appellant is absent despite summon notice. The PIO, the DMO Siang District, Dr. Tarik Talom is, however, present through the V.C.

The PIO submitted that the information sought for by the appellant vide his application dt.10.10.2023 had already been furnished to him vide letter dt.17.11.2023, a copy whereof, has also been forwarded to this Commission through Whatsapp.

However, the receipt of the information (complete or incomplete) by the appellant could not be confirmed due to his absence.

The hearing of this appeal is, therefore, adjourned again to 22.01.2025 on or before which date the appellant is directed to intimate to this Commission of his acknowledgment of the receipt of the information or attend the hearing on the next date failing which it will be presumed that he had received the information and satisfied therewith and accordingly close the appeal.

NOW THEREFORE, the parties are hereby summoned to appear in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC in person or online on the above date and time without fail.
