WARNING SUMMON

WHEREAS, in connection with the **APIC-No. 07/2025**, your personal appearance is required before the Commission on **25th November, 2025 at 01:30 PM**. The 2nd hearing held on **19th August, 2025**. Both the parties are absent during the hearing before the Commission.

The Appellant has not given any reasons for his absence.

In the first hearing held on 08.05.2025 also the Appellant was absent.

The PIO's representative Shri Tami Hokom, (Assistant Engineer), RWD, Raga Division present during the first hearing on 8th May' 2025, had stated before the court that the information(s) are ready in the office of the PIO and the Appellant to come and collect the information(s).

After hearing the representative of the PIO the Commission had ordered the Appellant to collect the information(s) from the office of the PIO and to be present in the next date of hearing which is today, failing which this instant appeal will be heard and determined ex-parte.

Despite of the order from this court the Appellant has failed to turn-up for the hearing for the 2nd time continuously.

In the absence of both the parties the hearing could not be proceeded, and therefore, **the Commission hereby orders as follows;**

- i) The Appellant to collect the information(s) from the office of the PIO and to be present in the next date of hearing without fail, failing which this instant appeal will be heard and determined ex-parte.
- ii) The PIO to be present in the next date of hearing without fail, failing which necessary action will be initiated against the PIO as per the provisions of RTI, Act, 2005.
- iii) Send the copy of this order to both the parties.

The Commission hereby orders;

The next date of hearing be fixed on 25th November, 2025' at 1:30 PM (Evening).


