**SUMMON NOTICE.**

**The 1<sup>st</sup> hearing** was held on **14<sup>th</sup> July , 2025** related to **APIC NO-1011/2023(R)/2025(Appeal)**. Appellant Shri Palen Laa present but PIO-Cum-DDMO, Raga, Kamle District found absent, however sent a letter regarding inability to attend the hearing.

The PIO also states that the documents are ready to be furnished on the payment of fee amounting to Rs. 7,650/- (Rupees seven thousand six hundred fifty) only through Treasury Challan HOA "0070". He also stated that despite, giving information the appellant has not collected the documents till date.

The appellant is also directed to collect the information from the office of the PIO and intimate to the Commission within 15 days information is collected.

The Commission adjourned the hearing and fixed next date of hearing on **27/08/2025 at 2 PM.**
