SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from ShriBalang Effa for non-furnishing of information by the PIO o/o the E.E, (RWD), Bameng Division, East Kameng district, (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 18.07.2024.

The appellant herein had requested the PIO, o/o the Chief Engineer (RWD), Govt. of A.P, Itanagar to furnish the information on PMGSY Road and Vibrant Village Programme in East Kameng District. In response the APIO, o/o the Chief Engineer(PMGSY), Itanagar, vide letter dt.19.07.2024, forwarded the said RTI application to the Executive Engineer/DPIU, RWD, Division Seppa / ChayangTajo / Bameng, East Kameng District requesting the said Divisions to furnish the requested information to the applicant as the information falls within their jurisdiction.

It transpires from the records that the applicant failed to obtain the information from the said PIO, o/o the Executive Engineer/DPIU, RWD, Division Seppa / ChayangTajo / Bameng and therefore, approached the First Appellate Authority (FAA), the S.E (RWD), Rupa Circle, Rupa, vide his Memo of Appeal dt. 05.09.2024 in response whereof the o/o the FAA, vide letter dt.06.09.2024, forwarded the Appeal Memo to the Executive Engineer/DPIU (RWD), Bameng Division, East Kameng District and requested the Division to furnish the information at the earliest. However, having failed to obtain the sought for information from the PIO, o/o the Executive Engineer/DPIU (RWD), Bameng Division, East Kameng District, the applicant / appellant filed this 2nd appeal before this Commission under section 19(3) of the RTI Act.

The appeal was accordingly, listed today on 06.12.2024 for hearing but the PIO did not appear nor did he depute his APIO or representative.

The appellant, who was present in person, reiterated his requested for the information he had sought. However, the hearing could not be concluded due to absence of the PIO.

The hearing is, therefore, adjourned to 17.01.2025.

You are hereby summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC in person **on the 17th January, 2025 (Friday) at 02.00 pm.** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

NOW THEREFORE, take notice that, in default of your appearance, on the day above-mentioned, the matter will be heard and determined in your absence.


