- (ii) The PIO to furnish all the information(s) to the Appellant as applied in his form 'A' application on or before next date of hearing. Failing which necessary action shall be initiated against the PIO as per the provisions of the RTI Act, 2005.
- (iii) Next date of hearing has been intimated to the Appellant. No formal notice required to be issued.
