**INTERIM ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Pema Tenba for non-furnishing of information by the PIO, o/o the Divisional Forest Officer Bomdila, West Kameng District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 05.09.2023.

The appeal is heard today on 8<sup>th</sup> November, 2024 as scheduled wherein the Appellant Shri Pema Tenba is absent but Shri Peter Tali, RFO, o/o the DFO Bomdila, West Kameng District, Department of Environment and Forest attended the hearing on behalf of the PIO. In this regard he submitted an authorization letter from the DFO.

The representative of the DFO informed that the materials are ready for handing over to the appellant. A copy of letter dated 01/11/24 addressed to the appellant advising him to collect the document from the o/o of the PIO on any working day has been furnished to this Commission.

Since the appellant is absent, the Commission directed the representative of the PIO to hand over the documents to the appellant at the earliest with intimation to the Commission.

The appellant shall collect the informations from the o/o the PIO and inform this Commission of his satisfaction or otherwise within 2 (two) weeks from the date of receipt of the information from the PIO whereafter the next date of hearing, if required, shall be fixed and intimated to the parties.
