**ORDER**

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Mamu Sono, Sood Village, PO/PS-Naharlagun, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the Public Information Officer (PIO), Govt. of A.P., O/o the District Panchayat Development Officer (DPDO), Changlang, Changlang District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 14/11/2023 regarding the 14<sup>th</sup> Finance Commission in the year 2018-19 and 2019-20.

2). **The 1<sup>st</sup> hearing is held today on 2<sup>nd</sup> June, 2024 as scheduled.** The Public Information Officer (PIO), Govt. of A.P., O/o the District Panchayat Development Officer (DPDO), Changlang, Changlang District, Arunachal Pradesh appeared before the Commission's court through Video Conferencing (Hybrid mode of hearing).

3). The PIO has submitted that actually he did not receive any application / Form-A of the Appellant but the same was provided during the hearing held before the First Appellate Authority (FAA).

4). The PIO also submitted that there are 132 Gram Panchayats and 50 Member Secretaries. Hence, collecting information from all within short period is not possible. However, he has collected some and provided through postal service.

5). The Commission, after going through the records and submission of both the parties it is found that: -

1. The information sought are vague and voluminous,
2. The information sought is regarding the 14<sup>th</sup> Finance Commission for the year 2018-19 and 2019-20.

The next date of hearing shall be fixed and intimated in due course of time.
