**SUMMON/ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Pisa Tapam for non-furnishing of below mentioned information by the PIO o/o the PD (RD) Koloriang, Kurung Kummey District Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 22.08.2024.

**Details of information required:**

1. Technology sanction order copy.
2. Name and address of contractors/firm/name of Firm owner/proprietor.
3. NIT copy if possible.
4. Details bid documents of contractor (Technical & Financial).
5. Name of work with Geo tag report of each project.
6. Details of payment with money receipt of contractors i.e. cheque book, counter foil/deposit Challan.
7. Account statement of department.
8. DPR copy.
9. MB book.
10. First and final bill.
11. Photocopy of work site from starting to end / certified photocopy of work site by the concern officer.
12. All documents in certified true copy.

**B. Period for which information asked for : 2021-24**

**Brief facts emerging from the appeal:**

Records emerging from the appeal disclose that the Appellant, Shri Pisa Tapam had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted him to appeal before the Deputy Commissioner, Koloriang, Kurung Kumey District, Arunachal Pradesh as the First Appellate Authority (F.A.A) under Section 19 (1) of the RTI Act vide his Appeal Memo dated 04.10.2024. But having failed to obtain any response from the PIO or the FAA the appellant filed his 2<sup>nd</sup> appeal before this Commission under section 19(3) of the RTI Act vide Memo of Appeal dt.10.12.2025.

The appeal was, accordingly, registered and listed for hearing for the 3<sup>rd</sup> time today. In the hearing fixed on 04.04.2025 none of the parties appeared. In the 2<sup>nd</sup> hearing fixed on 23<sup>rd</sup> April, 2025 also neither party appeared but the appellant had informed of his inability to attend the hearing due to an unavoidable domestic problem.

**Hearing and decision:**

In today's hearing the PIO is again absent without any information but the appellant, Shri Pisa Tapam is present in person. However, during the course of hearing the PIO was contacted over mobile phone who expressed his sincere regrets for not being able to attend the hearing due to his pre-occupation in an enquiry being conducted by the Anti Corruption Bureau (formerly SIC) in a 15<sup>th</sup> Finance Commission related case. The PIO, however, submitted that the requested documents/information shall be provided to the appellant by 30<sup>th</sup> May, 2025.

The assurance given by the PIO over mobile phone has been taken on record and accordingly, the PIO is directed to furnish the requested information to the appellant with intimation to this Commission on or before 30.05.2025. The appeal is again listed for hearing on 06.06.2025.
