ORDER

WHEREAS, in connection with the 2024, related to the APIC No-115/2024. Your personal is required before the Commission on 5th September at 10.30 AM. The Appellant Shri Riya Taram and his party found absent without intimating the reason for his inability to attend the hearing but the representative of the PIO Er Taj Toko (AE), present during the hearing.

WHEREAS, the representative of the PIO stated before the Commission that as per the order passed in last hearing on date 06/06/2024 all the information sought by the appellant are ready in his good office and the PIO also intimated the Appellant Shri Riya Taram to collect the information by depositing the requisite fees, but the Appellant did not turn up to collect the information till today.

After hearing the representative of the PIO, and going through the records, the Commission viewed seriously on the absence of the Appellants and their reluctant attitude by not complying the orders of the Commission. Thereby Commission ordered;

The Commission ordered:
