Order

WHEREAS, in connection with the **APIC-No. 201/2024**, the The 2nd hearing held on **8th August,2024** related to the **APIC No-197/2024**. The Appellant Shri Ngwazosa Yobin present during the hearing but the PIO found absent without intimating to the Commission the reason of his absence from the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO besides public duties, also has to attend Court hearings when an appeal is preferred against him as per the provisions of the RTI, Act,2005, which is a statutory duty binding upon the PIO.

The Appellant stated before the Commission that as per the order passed by this Court in the last hearing on dated 13/06/2024 the PIO has furnished the information(s) to him of serial no. 1, 4 & 5 but serial no. 2, 3 & 6 have not been furnished to him and he has produced the information(s) provided to him before the Commission during the hearing.

After hearing the Appellant, and going through the information(s) provided by the PIO, it is seen that the PIO has mentioned no records are available for the information(s) sought in serial no. 2, 3 & 6 so, the Commission ordered ;

- (i) To **summon** to the PIO to appear before the Commission in person in the next date of hearing.
- (ii) The PIO to let know the Appellant with whom the records are available. ***Failing which necessary action shall be initiated against the PIO as per the provisions of RTI Act,2005.***
- (iii) The next date of hearing has been intimated to the Appellant. No formal notice required to be issued.

The Commission ordered;

The next date of hearing is fixed on 19th September, 2024 at 10:30 PM (Morning)
