SUMMON

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram and others for non-furnishing of information by the PIO o/o the Executive Engineer (WRD) Bordumsa Division, Changlang District, Arunachal Pradesh as sought for by them under section 6(1) of RTI Act, 2005 vide application dated 19.07.2023.

This is for the 3rd time the appeal is listed for hearing today on 04.12.2024.

In the first hearing both the PIO and Appellant were absent.

In the 2nd hearing on 01.11.2024, the PIO was again absent without any intimation nor deputed any one to attend the hearing but one of the appellants, Shri Riya Taram was present.

This Commission, taking serious view of the continued absence of the PIO, had warned the PIO that if he fails to attend the next hearing i.e today, action under section 20 of the RTI Act shall be initiated against him.

In today's hearing also the PIO did not turn up but intimated through his J.E, Er. Shri Deo Sangno that he is unable to attend the hearing due to medical emergency and requested for adjournment of the hearing to an appropriate date.

This Commission considered the request of the PIO and with due consent of the appellant, the hearing of this appeal is adjourned to 15.01.2025 and directs the PIO, o/o the E.E. (WRD), Bordumsa Division, Changlang District to appear in person with the sought for documents (whatever is available) in the next hearing.

The next date of hearing of this appeal is fixed on 15.01.2025 (Wednesday) 10.30 am.

NOW THEREFORE, the parties are hereby directed to appear in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC in person on the above mentioned date and time without fail.
