## **ORDER**

The 1<sup>st</sup> hearing held on <u>1<sup>st</sup> October, 2024</u> related to the <u>APIC No-225/2024</u>. The Appellant Shri Ngurang Tingpho and the representative of PIO Er. Tad Logi, AE present during the hearing. Heard both the parties.
