**SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of information by the PIO, o/o the Project Director, DRDA, Koloriang Kurung Kumey District Govt. of A.P as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 01.05.2023.

This appeal is heard for 5<sup>th</sup> time today on 27/11/24 wherein the Appellant, Shri Tamchi Gungte and Er. Shri Nangram Logu, Assistant Project Officer (Technical), the APIO o/o the PD, (RD), Kurung Kumey District, Koloriang were present.

Heard the parties.

The APIO submitted that he was posted in Koloriang in the last part of 2022 and as such he has little or no knowledge of the documents but assured that he will collate and collect whatever documents available from the T.A-(RE) and furnish to the Appellant.

It is pertinent to note that in APIC case No. 743 (Bamang Pacho vs o/o the PD (RD), Koloriang) the Assistant Project Officer Er. Shri Nangram Logu, the APIO had been appointed as the PIO in that case since he was the Nodal Officer of the Project against which documents/information(s) sought by the Appellant, Shri Bamang Pacho pertains. In this particular appeal case also, since Er. Shri Nangram Logu is the Technical Officer In-charge, this Commission deems it appropriate to appoint him as the PIO in terms of Section-19(8) (a), (ii) of the RTI Act, 2005, who shall be responsible for furnishing the sought for documents to the Appellant.

In the premises as above, Er. Shri Nangram Logu, the APO, (Technical) is appointed as the PIO in this particular appeal and accordingly, directed to appear before this Commission on 18/12/24 with the documents/information sought for by the Appellant.
