Summon Notice.

The 12<sup>th</sup> hearing was held on 9<sup>th</sup> October, 2024 related to the APICs No-220/2023 and 417/2023 (Appeal). Appellant Shri Tasi Chader present, but the PIO-cum-PD, DRDA, Daporijo found absent without any information to the Commission.

**WHEREAS**, as per the case records, it is seen that the PIO has already deposited the penalty amount of Rs. 25,000/- (Rupees twenty five thousand) only which was imposed but the information sought by the appellant has not been furnished as per the Form A' application till date. The Project Director has not complied to the order of the Commission in spite of repeated summoned notice and even after imposing penalty.

**WHEREAS**, the PIO-cum-PD, DRDA, Daporijo is showing reluctant attitude to appear before the Commission and provide the information sought by the appellant. **Last chance is given to the PIO to be present in person before the Commission in the next date of hearing. Otherwise the Commission will be bound to recommend action against the PIO under Section-20(2) of the RTI Act.**

I have been appointed as CO, BDO, CD Block Lemiking for the Period 2023. The appellant Shri Tasi Chader sought information for the period from 2016 to 14<sup>th</sup> December, 2022. Such as I am unable to furnish any information details as sought by the appellant Shri Tasi Chader in this RTI application dated 14/12/2022 except whatever is available in the MNGREGA portal. Copy of the affidavit is submitted before the Commission and enclosed.

Shri Tasso Duri, PIO-cum-BDO, CD Block, Lemiking has already filed affidavit on 24/05/2023 stating that my predecessor, Shri Koj Tado did not handover any documents relating to material procurement and supply of MGNREGA.

All the remaining documents should be under Project Direction, DRDA, Daporijo.
