**ORDER**

**WHEREAS**, in connection with the **APIC-No. 204/2024**, your personal appearance is required before the Commission on **14<sup>th</sup> November'2024 at 10:30 AM**. **WHEREAS**, Due to absence of the PIO, the Commission could not proceed the hearing of the appeal and the Commission ordered;

- (i) To **summon** the PIO to appear in person or through online mode before the Commission in the next date of hearing.
- (ii) The PIO to furnish all the information(s) to the Appellant as applied in his form 'A' application on or before next date of hearing. ***Failing which necessary action shall be initiated against the PIO as per the provisions of the RTI Act, 2005.***
- (iii) Next date of hearing has been intimated to the Appellant. No formal notice required to be issued.
