





RUNACHAL PRADESH INFORMATION COMMISSION

ITANAGAR. An Appeal Case U/S 19(3) of RTI Act, 2005 Case No. APIC-233/2025. (Summon to appear in person) (Or.5, R.3 of CPC)

ORDER / SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Yamra Elia, for non-furnishing of below mentioned information by the PIO, o/o the Chief Engineer Hydro Power Development, Western Zone Govt. of A.P, Itanagar as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 24.09.2024

A) Particular of information: Fure MHP at Damin (1x50 kw)

B) Details of information required:

- 1. the official Technical Order copy;
- 2. The NIT paper (Local daily news paper) if not then reason to be furnished;
- 3. How many bidders attended with submission of EMD;
- 4. Name of the contractor or firm (if NIT);
- 5. The winner of NIT tender with name and documents;
- 6. The Lowest rate L1, L2, L3 and L4;
- 7. Order copy;
- 8. Agreement copy in between contractor and executing agency;

9. Deposit of BG in which bank by winner of tender;

- 10. Total Nos. of Financial bids;
- 11. Geo tag report;
- 12. Check leaf for payment against the contractor;
- 13. Signature copy of both members attended during tender and
- 14. Document should be sign and CTC copy.

C) Period for which information asked for: 2010

Records emerging from the appeal disclose that the Appellant, Shri Yamra Elia had requested the PIO for the aforementioned information /@ocuments but failed to obtain the same which prompted him to file appeal before the Chief Engineer (HPD), Govt of A.P (WZ), Itanagar, the First Appellate Authority(FAA) under section 19(1) of the RTI Act vide his Memo of Appeal dt.26.11.24. However, the appellant failed yet again to obtain the information and therefore, he preferred his 2nd appeal before this Commission under section 19(3) of the RTI Act, 2005 vide his Memo of Appeal dt.28.02.2025.

This appeal is listed and heard for the 2nd time today on 23.05.2025, the 1st time being on 30.04.2025 wherein the appellant Shri Yamra Elia and Er. Shri Taba Tagu, SW (C), the PIO were present in person.

On 30.04.2025, this Commission, upon hearing the parties and considering that the requested information are not held by the PIO, o/o the Chief Engineer (HPD), Govt of A.P (WZ), Itanagar, but by the o/o the E.E (HPD) Koloriang Division, who has been found to be the actual public authority holding the information sought for by the appellant, summoned him to appear in the hearing before this Commission and provide the requested information to the appellant.

This appeal was, thus, listed for hearing today on 23.05.2025 wherein the appellant is present in person but the PIO, the E.E (HPD) Koloriang Division is absent.

The appellant expressing his disappointment on the absence of the PIO in the hearing, pleaded for stringent action against him for disrespecting this Commission and its order.

The absence of the PIO has also been viewed seriously by this Commission despite this commission's summon order and the advice of the PIO, o/o the Chief Engineer (WZ) vide letter dt.29.04.25 and dt.16.05.2025.

This appeal is listed again on 2nd July, 2025 wherein the PIO, the E.E (HPD) Koloriang Division is directed to appear with the sought for information without fail so as not to compel this Commission take penal action under section 20 of the RTI Act, 2005.

NOW THEREFORE, you are hereby summoned to appear in person in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC on the 2nd July, 2025 (Wednesday) at 10.30 am to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
