SUMMON ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Teli Naga, Vice President (Pro) Arunachal Law Students Union (ALSU) P.O/ P.S- Banderdewa District, Papum Pare, AP, for non-furnishing of information by the PIO O/o the Chief Engineer PMGSY, ARRDA, RWD Itanagar, Govt. of Arunachal Pradesh, as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

The appeal was heard today on 19/06/2024 as scheduled wherein the Appellant attended the hearing online and the PIO attended offline.

The Appellant submitted that he had approached the First Appellate Authority, the Chief Engineer PMGSY, ARRDA, RWD.
