**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tamchi Gungte, Near, KV2 School, Chimpu, Itanagar, Arunachal Pradesh for non-furnishing of information by the SPIO-cum-EE (WRD), Govt. of A.P. Deptt. Water Resource Department, Namsai Division, Namsai District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 28/04/2023 regarding Construction of double storey RCC Hostel building with brick walling & CGI roofing for 100 girls at Govt. Hr. Sec. School, Namsai in Namsai Block of Namsai District, A.P.

**The 4<sup>th</sup> hearing is held today on 11<sup>th</sup> June, 2024 as scheduled.** Er. C.J. Manow, the PIO-cum-EE (WRD), Govt. of A.P. Deptt. Water Resource Department, Namsai Division, Namsai District, Arunachal Pradesh is represented by Adv. Bajongso Kri. The Appellant Shri Tamchi Gungte is present.

The counsel of the PIO brought some document during the hearing and furnished to the Appellant. Appellant received the same and appealed the Commission to give time for verification.

The Commission giving reasonable opportunity directs the Appellant to go through the information, intimate the PIO, if any short fall, and get complete information before the next date of hearing and intimate the commission for disposal of the case.

Both the parties are directed to appear before the Commission's court in persons on the next date of hearing. In case the PIO fails to appear, the Commission shall be compelled to invoke recommendation of disciplinary action against the PIO under section 20(2) of the RTI Act, 2005. In case appellant remains absent the Commission shall dispose of the case without any further notice, presuming that the Appellant is satisfied with the information so furnished by the PIO.

The next date of hearing is fixed on 2<sup>nd</sup> July, 2024 (Tuesday) at 1030 hrs.

Therefore, Er. C.J. Manow, the SPIO-cum-EE (WRD), Govt. of A.P. Deptt. Water Resource Department, Namsai Division, Namsai District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
