**SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Nabam Tapak, Gyamar Hina for non-furnishing of information by the PIO O/o the Executive Engineer (RWD), Sagalee Division District Papum Pare, Arunachal Pradesh as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

This appeal is heard for 4<sup>th</sup> time today on 11/09/24 as scheduled wherein the Appellant Shri Nabam Tapak is present but the PIO o/o the E.E (RWD), Sagalee Division is absent.

The Appellant submitted that the PIO is deliberately avoiding the hearing of this appeal and expressing his sheer disappointment over the continued absence of the PIO in the hearing on one hand and lack of stern action by the Commission on the other, demanded that appropriate action under the relevant provision of RTI, Act should be initiated against the PIO.

This Commission, considering the submission of the Appellant and also non-response from the PIO decides to issue show cause notice to him as to why action under appropriate Section of the RTI, Act shall not be taken against him.

The PIO shall furnish his replies to the show cause notice by next date of hearing fixed on **4<sup>th</sup> October, 2024 at 02.00 pm.**

**NOW THEREFORE**, The PIO O/o the Executive Engineer (RWD), Sagalee Division District Papum Pare A.P is hereby summoned to appear in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC in person or online on the above date and time without fail.
