ORDER

1. This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tania June, c/o of Post Office Naharlagun Arunachal Pradesh for non-furnishing of information by the State Public Information Officer (SPIO), Govt. of A.P. Department of PWD Capital Circle-cum-Coordination Training & Vigilance, Itanagar as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 13/03/2023 regarding appointment of under Junior Engineer (JE) Civil, Sports Quota / Handicapped/General of advertisement Date on 26th, 27th, 28th, 29th September 2016.
2. **The 7th hearing was held on 1st October, 2024 as scheduled.** Shri S.T. Tara, the Public Information Officer (PIO), Govt. of A.P. Department of PWD Capital Circle-cum-Coordination Training & Vigilance, Itanagar attended the hearing through online mode of hearing (Video Conferencing). The Appellant Shri Tania June attended the hearing in person
3. The Appellant submitted that the PIO had not furnished information as directed by the Commission in the last hearing.
4. The PIO informed the Commission that due to delay in supply of information from the district branches, the information could not be furnished to the Appellant in time. However, information are available now and that the Appellant could collect the same from the office on any working day.
5. The Commission asked the Appellant to collect the information from the office of the PIO after the hearing. If no further observation, the Appellant could give it in writing to the Commission, under intimation to the PIO, so that the case could be closed and disposed of.
6. If the case is not resolved, both the parties are directed to appear before the Commission's court in person on the next date and time of hearing without fail. In case the PIO fails to appear, the Commission shall be compelled to invoke disciplinary action against the PIO under section 20(2) of the RTI Act, 2005. In case appellant remains absent the Commission shall dispose of the case without any further notice, assuming that the Appellant has received the information and is satisfied with the same as furnished by the PIO.

The next date of hearing is fixed on 5th November, 2024 (Tuesday) at 1030hrs (Morning).
