This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Dongru Tania for non-furnishing of 25(twenty five) point information regarding the expenditure and implementation on CAMPA Schemes/VRF/ARF under the DFO, Kra Daadi District by the PIO, o/o the Divisional Forest Officer (DFO) Palin, Kra Daadi District A.P as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dt.29.05.2023...

The appeal was taken up for hearing today on 25.09.2024 wherein the Appellant Shri Dongru Tania and Shri Najik Talit, RFO, Palin, the API0 o/o the DFO, Kra Daadi District were present.

During the hearing the APIO brought in a copy of letter dt.20.10.2023 addressed to the Appellant advising him to collect the sought for information from the o/o the PIO by depositing a sum of Rs. 284.00 (Two hundred eighty four) being the cost of stationary. The Appellant, however, submitted that he did not receive the said letter from the PIO.

Be that as it may, since APIO has brought in the sought for information, the same has been handed over to the appellant and directed him to go through the them and report his satisfaction of otherwise to this Commission on or before 30.10.2024 i.e the next date of hearing of the appeal.
