ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Taguk Dada for non-furnishing of information by the PIO, o/o the DDSE Boleng, Siang District A.P as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

The Appellant, Shri Taguk Dada, vide his application dt.16.02.23 had requested the PIO, o/o the DDSE, Boleng, Siang District for the following information:

- (a) Lists of regular MTS/LDC/UDC serving under the department of Education, Siang District along with their names, date of appointment and place of posting.
- (b) Lists of regular PRT/TGT serving under Siang District along with their name, date of appointment and place of posting.
- (c) Lists of regular (non-teaching) staff serving under Siang District along with their name, date of appointment and place of posting.
- (d) Lists of SSA/ISSE Teachers serving under Siang District along with their name, date of appointment and place of posting.
- (e) Lists of contractual (non-teaching) staff serving under Siang District with their name, date of appointment and place of posting.
- (f) Lists of regular/contingency/contractual staffs appointed after August 2018 along with their name, date of appointment and place of posting.
- (g) Lists of staffs retired from service since 2016 along with their name, date of retirement and the post he/she held at the time of retirement.
- (h) Furnish total vacant post under the department of education, Siang District till date.
- (i) Furnish number of recruitment examination held till date along with copy of advertisement.

The Appellant, having failed to obtain the information from the PIO, filed 1st appeal before the First Appellate Authority, the Deputy Commissioner, District Siang, Boleng vide his Memo of Appeal dt. Nill under section 19(1) of the RTI Act, 2005. However, having failed to receive the information, despite his appeal before the FAA, the appellant preferred this 2nd Appeal before this Commission vide his application dt. Nill which was received in the Commission on 27.08.2023.

The appeal was taken up for hearing in this Commission today on 28.08.2024 wherein the Appellant was absent but the APIO, o/o the DDSE, Boleng attended the hearing along with the copy of 'DOCUMENTS RECEIPT' dt. 06.08.2024 from the Appellant, Shri Taguk Dada stating therein that *he has received all the documents from the o/o the DDSE, Boleng on 07.08.2024 and also declaring therein that he shall not seek any further information regarding the subject from the DDSE, Boleng.*

This Commission perused and considered the copy of the said 'Documents Receipt' and the declaration made therein by the Appellant and holds that this appeal does not warrant any intervention of the Commission and accordingly, this appeal is disposed of and closed.
