ORDER

WHEREAS, the 3rd hearing held on 26th November, 2024 related to the APIC-No-191/2024. The Appellant Shri Dawa Tsering, present in person. The PIO-cum-Divisional Forest Officer (DFO), Bomdila Division, West Kameng District, Govt. of Arunachal Pradesh, is found absent for three consecutive hearings.

Heard the Appellant:

The Appellant stated that no information(s) has been provided to him by the PIO till date.

The Commission observed:

Despite orders from the Commission to attend the hearing of this appeal, on 18.06.2024, 30.07.2024 and 26.11.2024 the PIO is absent for three consecutive times which is contempt of the order of this Court.

The Commission ordered:

(i) The Secretary/PCCF, Department of Environment and Forest, Govt. of Arunachal Pradesh to initiate disciplinary action against the PIO-cum-(DFO) Bomdila Division, West Kameng District, Govt. of Arunachal Pradesh, as per the Service Rule applicable to the PIO. The copy/report of the disciplinary action initiated against the PIO-cum-DFO, Bomdila Division, West Kameng District, Govt. of A.P, be intimated/sent a copy to this Commission, failing which necessary action shall be initiated against the Secretary/PCCF, Department of Environment and Forest, Govt. of A.P, as per the provision of Section 25(5) of RTI, Act, 2005.

(ii) Summon notice be issued to the PIO to appear in person or through online mode before the Commission in the next date of hearing.

(iii) Notice need not be issued to the Appellant as he has been already intimated in the Court.

The Commission ordered;

The next date of hearing be fixed on 4th February' 2025 at 1:30 PM (A/Noon)
