ORDER

This is an appeal filed under sub-section (3) of the Section 19 of the RTI Act. 2005. Brief fact of the case is that the appellant Shri Tajum Dadi on 27.03.2023 filed an RTI application in Form-A to the PIO O/o PIO-Cum-EE, PHED & WS Division Daporijo Upper Subansiri District A.P., whereby, seeking various information as quoted in Form-A application.

Appellant being not received information from the PIO, filed the First Appeal before the First Appellate Authority Cum SE PHED & WS Yachuli Camp- Naharlagun Govt. of A.P. on 24.05.2023.

Appellant again having not received the required adequate information or decision from FAA, filed the Second Appeal before the Arunachal Pradesh information Commission on 29.06.2023.

The Registry of the Commission (APIC), on receipt of the appeal, registered it as APIC-No.603/2023 (Appeal) and processed the same for its hearing and disposal.

Accordingly, this matter came up for 3rd hearing before the Commission Court today on 26.08.2024. Notice of hearing dated 03.07.2024 were served to PIO and the Appellant.

In this hearing of the appeal on 26.08.2024 the respondents PIO Shri Dulom Tago, EE, PHE & WS Daporijo Division, Upper Subansiri District A.P present. The appellant Shri Tajum Dadi has appeared.

Heard the parties present.

The appellant states that he has received partial information and he has sought complete information through a written submission to the PIO. The additional information is not yet furnished to him.

The PIO submits that additional information is ready and produced a forwarding letter dated 16.8.2024 of information to the appellant and has brought the information in the court and handed over the same to the appellant. The appellant has received the documents and desire to examine the fullness and correctness of the information document.

After hearing both the parties the commission has granted the appellant to verify the information furnished to him. If still there is shortcomings in the information furnished to him, he shall file a written submission to the PIO clearly specifying shortcomings in the information without deviation from the content in the original RTI application in form A within ten days from date of receipt of this order.

Upon receipt of such written submission, the PIO shall furnish complete and correct additional information to the appellant within two weeks from the date of receipt of such written submission.

The appellant shall serve a copy of this order to PIO along with his written submission if any and obtain acknowledgement receipt from PIO/office. Submit a copy of acknowledgement receipt obtained from PIO /office or a report of correctness of the information to commission within a period of three weeks from the date of receipt of this order for further hearing / closure of this appeal case.

The hearing is adjourned. Next date of hearing shall be fixed in due course of time after receipt of compliance report from PIO and appellant.
