ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Yiter Lombi, Library Guwahati High Court Permanent Bench Itanagar for non-furnishing of information by the SPIO-cum-EE(PWD) Govt. of A.P.Basar Division, Leparada District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 25/11/2022 regarding c/o Road from Nyigam Kamdak to Nyigam Galim at Basar.

The 6th hearing is held today on 30th April, 2024 as scheduled. Shri Dakli Kato, the PIO-cum-EE (PWD) Govt. of A.P.Basar Division, Leparada District, Arunachal Pradesh and the Appellants Shri Yiter Lombi are present. The Appellant submitted that he has not been furnished with all the information; on the other hand the PIO has submitted that he has furnished all the available information on 9th January, 2024 but he has not brought valid document to proof of his action taken.

Therefore, the Commission directs both the parties to appear before the court on the next date of hearing with proper homework and preparation, the PIO is directed to bring all the copies of the document furnished to the Appellant to substantiate his claim that he has furnished same in the month of January.

Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the SPIO is found absent the Commission recommend for disciplinary action as per provision under section 20(2) of the RTI Act-2005 and in case Appellant is found absent the case shall be disposed of without any further notice, presuming that the Appellant is satisfied with the information so furnished.

The next date of hearing is fixed on 18th June, 2024 (Tuesday) at 1030hrs.

Therefore, Shri Dakli Kato, the SPIO-cum-EE (PWD) Govt. of A.P.Basar Division, Leparada District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
