## **ORDER/SUMMON**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri TamchiGungte for non-furnishing of below mentioned information by the PIO, o/o the Chief Executive Officer, Pasighat Smart City Development Corporation Ltd, Pasighat, East Siang District, Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 23.09.2024.

A) Particular of information: c/o "Construction of Smart Road Phase I and II and storm Water Drains Phase I under Pasighat smart City Mission Road and Drain Etc." DURING THE FINANCIAL YEAR 2021-22.

## B) Details of information required:

- 1. Certified Sanction Order copy;
- 2. Tender Evaluation copy of Technical Bid along with list of Firms participated in the Tender process for the work;
- 3. Name of Firms who won the tender work with respect to the subject mentioned above;
- 4. Certified Design and scope of work in the projects;
- 5. Certified copy of work specification of the projects;
- 6. Certified copy of completion certificate for the work with respect to the subject mentioned above;
- 7. Certified copy of Contractor Registration, GST No. Contractor Enlistment Update reports as nature of work of tender winning Firm;
- 8. CTC copy of declaration letter from the contractor to the effect that he/she has not been debarred from tendering by authority (if the contractor is from different state) in which contractor is registered;
- 9. Certified Copy of utilization certificate;
- 10. Certified copy of Notice Inviting Tender (NIT);
- 11. Certified copy of newspaper in which NIT was published (At least 3 newspaper name (one national & 2 Local) along with date of publication of news paper, as per government approved order;
- 12. Certified copy of EMD and Security money deposited by all the tender participant;
- 13. Certified Integrity Pact submitted by the tender participant;

14. Certified copy of an Affidavit copy sworn before a competent Magistrate by the Contractor, to the effect that he does not have two or more incomplete ongoing commitments (project to execute / contracts in hand) (Notification no. SPWD/W-

15. Certified copy of three similar work each of value not less than 40 % of the estimate cost or two similar work each of value not less than 60 % of the estimated cost or one similar work of value not less than 80 % of the estimated cost in the last 5 years ending last day of the month previous to the one which tender are invited.

This appeal was, heard on 09.04.2025 wherein both the appellant, Shri Tamchi Gungte and Er. Shri Bengia Gagung, E.E, o/o the CEO, PSCDC Ltd. were present.

This Commission, upon hearing the parties and on perusal of the requested documents / information, directed the PIO to furnish the Contractor Registration/ Enlistment Certificate leaving the personal information like the IT returns etc. The PIO was also directed to furnish the UCs and the date of publication of the NIT in the

The PIO was directed to comply with the direction as above on or before 9th May, 2025 and the Appellant was also directed to intimate within one week thereafter the receipt of the information/document to this Commission.

The appellant, Shri Tamchi Gungte, vide his letter dated 21st May, 2025 intimated the Commission that the PIO has not complied with the order of the Commission and, therefore, requested for hearing the appeal again.

In the premises as above, the PIO, o/o the Chief Executive Officer, Pasighat Smart City development Corporation Ltd. Pasighat, East Siang District, Arunachal Pradesh is, therefore, summoned to appear in person with the documents in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC on 4th July, 2025 (FRI DAY) at 2 PM to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

NOW THEREFORE, take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
