**ORDER.**

The 3<sup>rd</sup> hearing held on **21<sup>st</sup> November, 2024** related to the **APIC No-216/2024**. The Appellant Shri Lenzing Pertin heard through online mode but the PIO absent with a letter of absence submitted to the Commission explaining the reason for his inability to attend the hearing, due to health issues.

Heard the Appellant.

The Appellant stated before the Commission that as per his application he had applied for inspecting the documents/information(s) at the office of the PIO. The PIO has allowed him to inspect the documents on 8/11/2024. After inspecting the documents at the office of the PIO/DLRSO, ESD, the Appellant has made his request to the PIO to provide him the information(s) pertaining to: Govt correspondence for land allotment at Gumin Nagar, Pasighat, the list of the persons allotted land at Gumin Nagar from 2003 to 2024, correspondence letter (s) for allotting land for the plot No. 101 & 227 and to provide the land allotment order copy of the said two plot and to specify whether they are allotted for Residential or Commercial purposes.

After hearing the Appellant, and going through the RTI Application of the Appellant, Commission ordered;

- (i) To PIO to provide all the information(s) to the Appellant on or before next date of hearing as sought in his form 'A' application. **Failing which action under section 20(2) shall be initiated against the PIO as per the provisions of RTI Act, 2005.**
- (ii) The Appellant to intimate to this Commission receipt of the information in-complete or not, on or before next date of hearing.
- (iii) Next date of hearing has been intimated to the Appellant and the PIO. No formal notice required to be issued.

The Commission ordered;
