An Appeal Case U/S 19(3) of RTI Act, 2005. Vide Case No. APIC-142/2024

The 4th hearing held on 14th November, 2024 related to the APIC No-142/2024. The Appellant Shri Pem Dondup Thangkhar and Shri Khandu Thongkar and the PIO-cum-Executive Engineer, PHE, Department, Dirang Sub-Division, West Kameng District, are present through online mode during the hearing before the Commission.
