Summon Notice.

The 1st hearing held on **12th November, 2024** related to the **APIC-No-943/2023**. The PIO is represented by Shri Duge Lollen (Assistant Engineer-cum-APIO), WRD, Aalo Division, West Siang District, Arunachal Pradesh. Heard the APIO:

- (ii) ***To issue summon to the Appellants to appear in person or through online mode in the next date of hearing. Failing which their appeal shall be decided ex-parte.***
- (iii) Next date of hearing has been intimated to the APIO. No formal notice required to be issued.

The next date of hearing be fixed on 16th January' 2025 at 10:30 AM (Morning)
