ORDER

The 1st hearing held on **8th May, 2025** related to the **APIC No-07/2025**. The Appellant Shri Serpi Flago is present. The PIO-cum-EE, RWD, Raga Division, Kamle District, Govt. of Arunachal Pradesh is represented by Shri Tami Hokom, (Assistant Engineer) RWD, Raga Division during the hearing before the Commission.

Heard the Appellant;

The Appellant stated before the Commission that he has not received any information(s) from the office of the PIO even after Form-A application was sent through Indian Postal Service from Doimukh on 30.09.2024, and by the records of the Indian Postal Service the Form-A was delivered to the PIO on 3.10.2024.

Heard the representative of the PIO;

The representative of the PIO stated before the Commission that the office of the PIO received the Form-A application of the Appellant late, after receiving notice of hearing on 25.02.2025 then the PIO collected the Form-A application of the applicant from the office of the State Information Commission, APIC, on 04.03.2025, so to provide the information(s) to the Appellant and the information(s) have been brought before the court to hand over to the Appellant.

After hearing both the parties and going through the Form-A application of the Appellant: **the Commission hereby observes;**

- (i) The number of information(s) that the Appellant has asked for, from the PIO seems to be too voluminous to be provided within the stipulated time as per the provisions of RTI, Act, 2005.
- (ii) It is also observed that even though the information(s) sought are too voluminous the PIO has not communicated anything in that regard to the Appellant.
- (iii) On receipt of the Form-A application from the office of the State Information Commission the PIO has compiled and readied the information(s) to be furnished to the Appellant.

After hearing both the parties the Commission hereby orders;

- (i) The Appellant to receive the information(s) from the representative of the PIO in the court today.
- (ii) To go through the information(s) diligently and see if complete information(s) have been provided or not and report the Commission on the same on or before the next date of hearing by attending the next hearing without fail, failing which this appeal will be dismissed ex-parte.
- (iii) Notice for the next date of hearing need not be sent to both the parties as both parties are present in the court today.

The next date of hearing is fixed on 19th August' 2025' at 2:30 PM (Evening).
