**WARNING SUMMON**

WHEREAS, in connection with the APIC-No. 209/2025, your personal appearance is required before the Commission on **09 December, 2025 at 01:30 PM**. The **5<sup>th</sup> hearing held on 28<sup>th</sup> August 2025**. The Appellant Shri Yomjum Nguba, found absent during the hearing with a letter of absence submitted by a friend of the Appellant Shri Mallo Topu, in the letter it is stated that he is unable to attend the Court due to some unavoidable domestic problems and he requested the Commission to postpone the hearing today and re-fix it on another day.

The PIO -cum PD, DRDA Likabali, is also absent during the hearing without intimating to the Commission the reason for his inability to attend the hearing, but it is to be put on records that the PIO had furnished all the information(s) to the Appellant in the Court, while hearing on 3/4/2025 in the Court of the Commission.

Due to absence of both the parties the Commission could not ascertain from both parties whether the information(s) provided to the Appellant by the PIO on 3/4/2025, is complete or not. In the 4<sup>th</sup> hearing which was held on 3/4/2025 the Commission had ordered the Appellant to receive the information(s) from the PIO.

After going through the set of information(s) to let the Commission made know that the information(s) are provided completely or not today in the 5<sup>th</sup> hearing, but due to absence of the Appellant, the fact could not be ascertain as to the information(s) have been provided to the Appellant completely or not.

The Commission seriously viewed the absence of both the parties and herby orders;.

- i) To fix another hearing to hear the Appellant to ascertain whether the information(s) have been provided to him by the PIO completely or not.
- ii) The Appellant to attend the next date of hearing without fail, **failing which his appeal will be heard and determined ex-parte.**
- iii) The PIO to attend the next date of hearing on the date mentioned below in person or through online mode to ascertain from him whether the information(s) provided to the Appellant was complete or not.
- iv) The next date of hearing has been intimated to both the parties. No formal notice required to be issued.

The Commission ordered;

The next date of hearing be fixed on 9<sup>th</sup> Dec' 2025 at 1:30 PM (Afternoon).
