ORDER

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tamchi Gungte, Near, KV2 School, Chimpu, Itanagar, Arunachal Pradesh for non-furnishing of information by the SPIO-cum-EE (WRD), Govt. of A.P. Deptt. Water Resource Department, Namsai Division, Namsai District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 28/04/2023 regarding Construction of double storey RCC Hostel building with brick walling & CGI roofing for 100 girls at Govt. Hr. Sec. School, Namsai in Namsai Block of Namsai District, A.P.

2). **The 5th hearing is held on 2nd July, 2024 as scheduled.** Shri C.J. Monnou, the PIO-cum-EE(WRD) Govt. of A.P., WRD Namsai Division, Namsai District, Arunachal Pradesh is represented by Adv. Bajangso Kri through Video Conferencing (Hybrid mode of hearing). The Appellant Shri Tamchi Gungte is present in the court room.

3). The Appellant was furnished with some documents by the representative of the PIO during the last hearing held on 11th June, 2024. The Commission on the appeal of the Appellant gave reasonable opportunity to verify the documents. The Appellant was also directed to give the list of unfurnished information as sought in Form-A to the PIO, if any.

4). The representative of the PIO has submitted that he has deposited the penalty amount as directed by the Commission and a copy of Treasury challan has also been submitted. Further, he has submitted that the remaining information has been furnished to the Appellant. The Appellant informed that he has furnished remaining information through Whatsapp. The Appellant insisted for authenticated information in hard copies.

5). After considering the submission of both the parties and in perusal of the records available, the commission came to the conclusion that all the information with authentication will be furnished through registered AD postal service in the address of the Appellant within twenty days from the date of issue of this order. The same should be intimated to the Commission. The court is adjourned for the next date of hearing.

6). Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the SPIO is found absent the Commission may initiate penal provision under section 20(1) of the RTI Act 2005 and in case Appellant is found absent the case shall be disposed of without any further notice, presuming that the Appellant is satisfied with the information furnished by the PIO.

The next date of hearing is shall be fixed and intimated in due course of time.
