ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tania June for non-furnishing of information by the Deputy Commissioner-cum-PIO Leparada District A.P as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 05/08/23.

This appeal is heard today on 18/10/24 wherein the Appellant Shri Tania June is absent but the PIO, Dr. Ms M.N Taloh (EAC) attended the hearing through Video Conference (V.C).

During the hearing, the PIO informed that she did not receive the Form-A submitted by the Appellant and hence, requested this Commission to forward the copy of Form-A to her.

As mandated under Section 19 (1) of the RTI Act,2005, the First Appellate Authority, following the principle of natural justice, has to conduct hearing giving fair and equal opportunity to the Appellant and the PIO and thereafter pass a reasoned and speaking order on merit.

Since the F.A.A has not adjudicated on the appeal, this appeal is accordingly, remanded to the F.A.A, the Deputy Commissioner, Leparada District, for adjudication within 30(thirty) days from the date of receipt of this order and the Applicant/Appellant, Shri Tania June is directed to appear before the F.A.A along with the documents more particularly, the copy of his application dated 05/08/23 and the copy of Appeal Memo dated 06/12/23 before the F.A.A, for hearing when called for and thereafter, the PIO, shall comply with the order of the F.A.A within 2(two) weeks from the date of F.A.A's order with liberty to the Appellant to prefer second appeal before this Commission under section 19 (3) of the RTI Act, if he is aggrieved/ dissatisfied with the order passed by the

F.A.A, or with the information furnished by the PIO for which no fee need be paid.
