Order

The 1st hearing held on 13th June ,2024 related to the APIC No-1/2024 (Complaint). The representative of PIO Shri Mokar Karlo (Divisional Accountant) present during the hearing and the Complainant heard through online mode.

Heard both the parties.

The Complainant stated before the Commission that though a bit late in providing the information to the Complainant; the PIO has provided him the information as applied by the Appellant.

The Complainant stated that the information given to him was insufficient and not prudent pertaining to the information(s) as sought by the Complainant. Therefore, the information be given to him in full, as applied in his Form 'A' Application.

After hearing both the PIO and the Complainant, the Commission by using its judicial mind ordered that;

The PIO provide the information(s) in sworn affidavit to the effect that;

- *i.* The reasons for delay of more than a month to provide information to the Complainant.
- ii. Whether the appointment of Ms. Mayir Koyu Giba, W/o late Nyachen Giba is effected on compassionate ground.
- *iii.* Any person(s) appointed under the compassionate ground by the office of the Executive Engineer Electrical Division, Likabali from 07/04/2021 to 18/12/2023.

Next date of hearing has been intimated to both the parties. No formal notice required to be issued.

The next date of hearing is fixed on 8th August, 2024 at 10:30 Am (Morning)
